Drugs used in feed manufacturing

Dear Ms. C---:

In your June 18, 1985 letter to Mr. Dalton B. Leech, Senior Tax Auditor for the Board's [city] office, which was referred to the legal section for response, you write:

Enclosed, please find a list of all the drugs we are using in the feed manufacturing process.

I have given the name of the drug, what it is used for and the type of drug.

We would like to have a ruling from the Board as to whether these drugs are taxable or not. As soon as we receive a ruling on the attached list, we will notify all our vendors accordingly.

I have enclosed with this letter, as Attachment A, the list you included with your letter. I assume that all the substances listed on Attachment A are, in fact, incorporated into the feed which --- uses or sells, and I also assume the feed so used or sold is feed for animal life of a kind the products of which ordinarily constitute food for human consumption.

Our opinion is that all these substances are nontaxable under the assumptions noted above, regardless of whether the substance is used to promote growth or to prevent disease in animals which consume the feed. Under Sales and Use Tax Regulation 1587(b), vitamins and minerals added to exempt feed to promote growth become part of the exempt feed and may be purchased from vendors ex-tax for this purpose. Likewise, those drugs and medicines added to exempt feed to prevent and control disease, may be purchased from vendors ex-tax for this purpose, since the resulting product is exempt medicated feed. Regulation 1587(b)(2)(B).
