Hazardous Waste Facility Fee Rates for 2025-2026 and Upcoming Due Date Reminder

The Board of Environmental Safety (BES), which oversees the Department of Toxic Substances Control (DTSC), determines the Hazardous Waste Facility Fee rates by October 1 of each year. The fiscal year 2025-2026 fee rates for the return due on March 2, 2026, are shown below, according to the BES emergency regulations adopted on September 25, 2025.¹

Upcoming due date reminder

Payments and return due dates for fiscal year 2025-2026 (July 1, 2025–June 30, 2026), are as follows:

- Prepayment—Due on or before December 1, 2025. The prepayment must equal 50 percent of the fee due for the fiscal year.
- Return and final payment—Due on or before March 2, 2026. This payment covers the remaining 50 percent of the fee due for the fiscal year.

You are required to pay the Hazardous Waste Facility Fee prepayment and file your return electronically through our Online Services system at *onlineservices.cdtfa.ca.gov*/_/.3
