International Fuel Tax Agreement (IFTA) Registration and Reporting Requirements for Alternative Fuels: Electricity, Hydrogen, and Hythane

All fuels defined in the IFTA Articles of Agreement must be reported on an IFTA tax return. This includes alternative fuels such as electricity, hydrogen, and hythane.

Interstate carriers must register their qualified motor vehicles propelled using electricity, hydrogen, or hythane for an IFTA license and decals, and they must report all miles driven and fuel purchased on their IFTA returns.

A qualified motor vehicle is one that is used or designed to transport people or property and meets any of the following requirements:

- Has three or more axles regardless of weight, or
- Has two axles and a gross vehicle or registered gross vehicle weight of more than 26,000 pounds or 11,797 kilograms, or
- Is used in a combination that has a combined or registered gross vehicle weight of more than 26,000 pounds or 11,797 kilograms.

Although California does not currently have IFTA tax rates for electricity, hydrogen, or hythane fuel types, other states do. Therefore, carriers in California who use these fuel types in the power unit of their vehicle must still report on their IFTA returns their mileage and fuel using kilowatt-hours (kWh) for electricity, diesel gallon equivalents for hydrogen, and gasoline gallon equivalents for hythane.

When California establishes an IFTA tax rate for any of these fuels, we will notify you by email.
