## Re: Cigarette and Tobacco Products Licensing Act Law Section 22990.7, Annual Report to the Legislature

Dear Chairman Wiener:

Pursuant to the requirements of the Cigarette and Tobacco Products Licensing Act Law Section 22990.7, this report summarizes the California Department of Tax and Fee Administration's (CDTFA) data about whether the annual licensing fee funding levels are set at an appropriate level to maintain an effective enforcement program for the *Cigarette and Tobacco Products Licensing Act of 2003*. This report includes the total revenue collected and total cost incurred during fiscal year 2023-24, as well as the beginning and ending balances of the Cigarette and Tobacco Products Compliance Fund (Fund 3067).

Effective January 1, 2025, Chapter 849, Statutes of 2024 (AB 3218) and Chapter 462, Statutes of 2024 (SB 1230) enact the Unflavored Tobacco Products List and includes enforcement authority for flavored tobacco products and tobacco product flavor enhancers. The funding for these additional activities will create a structural imbalance in Fund 3067, requiring reliance on the fund balance and may create pressure to increase licensing fees in the future to maintain the current level of administration of the Program.
